Consolidated Concrete may decline further credit purchases if any portion of the account is past due.

Any returned checks or checks not paid by the issuing bank may be assessed a \$30.00 processing fee (or the maximum allowed by law).

Any and all changes to applicant organization (Name Change, Change in Ownership, etc...) must be notified to Consolidated Concrete immediately and may constitute a cease in all credit purchases. A new application must be submitted to Consolidated Concrete, unless the change is otherwise accepted by Consolidated Concrete.
